### - PRODUCT DESCRIPTION

SVITOL BIKE BIKE DETERGENT is an alkaline detergent, ready to use, designed for cleaning all parts of the bike. The product effectively removes all types of dirt, even the most resistant: encrustations, dust, mud, smog, grease, and oil.

It can be used safely on all parts of the bike: frame, seat post, handlebar, shock absorbers, fork, wheels, pedaling mechanisms.

Safe on all materials such as carbon, aluminum, titanium, steel, anodized or painted surfaces, rubber.

#### - FIELDS OF USE

Product for the cleaning of every part of the bike: frame, seat post, handlebar, shock absorbers, fork, wheels, pedaling mechanisms.

It can also be used on scooters with good results.

#### **METHOD OF USE**

• Work on cold material and not in direct sunlight.

• Spray the Bike Detergent on the whole bike and let the product act for a few minutes (1-2 minutes), to dissolve the dirt.

- Remove stubborn dirt with a sponge or brush.
- Thoroughly rinse all parts of the bike with water

• Attention: <u>accumulations of mud and dirt must be</u> removed in advance with a jet of water.

Product validity in sealed packaging and stored at room temperature: at least 3 years
