SVITOL BIKE SUPER DEGREASER

- PRODUCT DESCRIPTION

SVITOL BIKE SUPER DEGREASER is a special solvent-based degreaser formulated to remove all residues from the bike transmission. The product will remove residues of grease, oil, dirt, tar, leaving no residue and evaporating completely.

The product is safe on all components of the bike transmission: chain, rear sprocket, front derailleur, sprocket, and rear derailleur. It does not require rinsing. It can also be used for cleaning disc brakes. Can also be used on e-bikes.

- FIELDS OF USE

Ideal for cleaning and degreasing all components of bicycle and e-bike transmission. Also useful on disc brakes.

METHOD OF USE

Act on cold surfaces and not exposed to direct sunlight. **SHAKE WELL BEFORE USE**.

Light soiling: apply abundantly on the chain, sprocket group and front derailleur.

Allow to drain and remove excess with a soft cloth.

More stubborn dirt: spray generously on the part to be treated, then pass a brush. Dispense abundantly again, eliminate any excess product by passing the chain over a soft cloth. Finally, let it dry. The chain is now ready to be lubricated. If unsure of surface compatibility, test the product on a small hidden area before use. <u>Do not use on rubber, plastic, and painted surfaces</u>

-CAUTION:

Test compatibility with the material to be treated before starting. Do not apply to hot surfaces.

- STORAGE

Product validity in sealed packaging and stored at room temperature: at least 3 years

- PACKAGING

Spray can with smart cap double position.
