Its formulation is particularly suitable for resisting washout and protecting the components from mud and dirt, making the product suitable for off-road rides or in case of rain and high humidity. The ceramic micro-flakes are able to penetrate and adhere to the micro-roughness of the metal surface, making the product ideal for the lubrication of the entire movement system: chain, rear derailleur, derailleurs, sprocket set, cables, levers.

The special EP additive package allows maximum efficiency even in the event of heavy effort, such as competitions and ultra-trails.

Also ideal for E-bikes.

- FIELDS OF USE

Product intended for the lubrication of all moving parts such as chains, rear derailleurs, derailleurs, sprockets, cables, mountain bike levers, road bikes, racing bikes, e-bikes.

METHOD OF USE

- Clean carefully the drive chain, rear derailleur and sprocket set and dry.
- Shake the product well before use.

- Apply in small doses to the chain links while turning the pedals.
- Remove any excess product.

- CAUTION:

Avoid contact with brakes. Clean thoroughly in case of accidental contact.

- STORAGE

Product validity in sealed packaging and stored at room temperature: at least 3 years
